# SUBJECT: CALVERT CLIFFS NUCLEAR POWER PLANT – NRC SUPPLEMENTAL INSPECTION REPORT 05000317/2011406 AND 05000318/2011406

Dear Mr. Gellrich:

On December 15, 2011, the U.S. Nuclear Regulatory Commission (NRC) completed a supplemental inspection at your Calvert Cliffs Nuclear Power Plant, Units 1 and 2. The enclosed inspection report documents the inspection results, which were discussed on December 15, 2011, with you and other members of your staff.

In accordance with the NRC Reactor Oversight Process Action Matrix, this supplemental inspection was performed to follow-up on a performance issue which occurred in the third quarter of 2011. This issue was previously documented and assessed in NRC Special Inspection Report 05000317/2011403 and 05000318/2011403 and Final Significance Determination Report 05000317/2011405 and 05000318/2011405. The NRC was informed on November 11, 2011, of your staff's readiness for this inspection.

The objectives of this supplemental inspection were to provide assurance that: (1) the root causes and the contributing causes for the significant issues were understood; (2) the extent of condition and extent of cause of the issues were identified; and (3) corrective actions were or will be sufficient to address and preclude repetition of the root and contributing causes.

No findings were identified during this inspection.
