On 1/3/2012, Jack Gadzala called and provided the following information:

1 – Kewaunee did not start the "54 Average" process on 1/1/12 due to lack of operational software ("EmpCenter") from the vendor to support the 54 Average calculations.

2 – EmpCenter is widely used in industry (I did not ask for details). However, the 54 Average calculation appears not to be ready for anyone. Thus, a Kewaunee deployment date is not yet determined.

3 – Kewaunee's primary POC for the 54 Average process is MaryJo Haese (who I know). She is to advise me when a forecasted date for adoption is provided by the vendor.
