We are planning a LAR submittal that would revise the DAEC Operating License by modifying the Physical Security Plan to grant combined enhanced-weapons authority and preemption authority. The submittal is being made pursuant to proposed rule making for Part 73 (76FR6200) to grant combined preemptive authority and authority for enhanced weapons. The guidelines in Draft Regulatory Guide DG-5020 are being used in the development of the submittal.
