Dear Ms. Kray:

By letter dated March 25, 2010, Exelon Nuclear Texas Holdings, LLC submitted an Early Site Permit (ESP) application for Victoria County Station pursuant to Title 10 of the *Code of Federal Regulations*, Part 52. This application was subsequently docketed and a review by the U.S. Nuclear Regulatory Commission (NRC) staff was initiated. The enclosed schedule contains the revised milestones for both the safety and environmental review and updates the milestones presented in the letter dated August 30, 2010 (Agencywide Documents Access and Management Systems Accession Number ML102080704).

This revised schedule establishes a review of your application along with all other concurrent reviews of applications for ESPs, design certifications, and combined licenses. In developing the revised schedule there is a critical dependency on timely resolution of key topics of interest particularly for growth faults at the site. The schedule also assumes that your responses to future NRC requests for additional information are technically complete and transmitted within the stipulated timeframe. In addition, any new and significant changes or additions to the ESP application and supporting documentation could impact schedule completion dates. The changes to the enclosed revised schedule have been discussed with Mr. Joshua Tremble and Mr. David Distill of your staff.
