This shipment will consist of 8 x 30B "Heeled" Cylinders in sealed overpacks on 2 x 20' flatracks containing 54 kg of Uranium. RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, FISSILE (HEELS)

3) Transportation and Route Schedule
