2) Physical Description

This shipment will consist of 8 cylinders of Uranium Hexafluoride (UF6) in sealed overpacks. The cylinders are 30-B cylinders containing 12,320 kg Uranium enriched to less than 5% weight of U-235. UN2977, Radioactive Material, Uranium Hexafluoride, Fissile

3) Transportation and Route Schedule

The ocean transportation from Antwerp, Belgium to Baltimore, MD will be the responsibility of Atlantic Container Line. The inland transportation from Baltimore, MD to GNF/Wilmington, NC will be the responsibility of RSB LOGISTIC SERVICES, INC.
