I've checked Revision 4 and Revision 6 of the FSAR. The proposed changes in the response to Question 03.05.03-2 (RAI 3224), i.e., adding:

3H.6-2 C. R Russell, "Reactor Safeguards," published by MacMillian, New York,1962" to the FSAR as reference in Subsection 3H.6.6.6 has been completed, except it was added to subsection 3H.6.9. The reference is still numbered as 3H.6-2.

I'll leave it up to you to decide if you want NINA to re-submit the RAI response to set the record straight. But for now, the action has been completed and I can status the RAI as Closed and Resolved. It is not necessary to change your SER either.
