Subject: Braidwood Station Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan, Revision 12

In accordance with 10 CFR 50.54, "Conditions of licenses," paragraph (p)(2), Exelon Generation Company, LLC (EGC) is submitting Revision 12 to the Braidwood Station Security Plan. Changes to this document were implemented on December 30, 2011. In accordance with 10 CFR 50.54(p)(2), EGC is submitting these changes within 60 days of implementation (i.e., no later than February 28, 2012).

The Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan has been revised to:

1. Update the Table of Contents, page ii from October 2010 to October 2011.
2. Revise Section 7, page C-24 to correct the numbering of a reference from a Training and Reference Material (T&RM) to a procedure to align with the convention for numbering T&RMs and procedures established in AD-AA-101, "Processing of Procedures and T&RMs." Reference to T&RM SY-BR-101-3001 is revised to procedure SY-BR-101-502.

EGC has concluded that the changes are administrative in nature and do not decrease the safeguards effectiveness of the Braidwood Station Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan.

Attachment 2 contains Safeguards Information. Therefore, EGC requests that this information be withheld from public disclosure in accordance with 10 CFR 2.390, "Public inspections, exemptions, requests for withholding," paragraph (d)(1), and 10 CFR 73.22, "Protection of Safeguards Information: Specific Requirements," paragraph (a)(1)(i).
