GE-Hitachi Global Laser Enrichment LLC (GLE) hereby submits a Standard Practice Procedures Plan (SPPP) for GE-Aviation, (DOD Cage Code 07482), 1 Neumann Way, Evendale, OH 45215 location, doing business at 3901 Castle Hayne Rd, Wilmington NC, 28401, to the U.S. Nuclear Regulatory Commission (NRC) and request the issuance of an NRC Non-Possessing facility security clearance for this facility. To support project schedules, we request that NRC reviews and approvals be accomplished to support issuance of a facility clearance for this facility by January 30, 2012.
