On January 5, 2012, as a result of an 8(a) non-competitive solicitation, an indefinite quantity fixed price contract (NRC-HQ-12-C-10-0026) was awarded to BLH Technologies of Rockville, Maryland, to provide technical editing support for the NRC. On January 11, 2012, Office of Information Services staff met with staff from the NARA and discussed the NRC's use of NARA's Electronic Federal Records Center (eFRC). The eFRC is a possible option for the management and storage of the NRC's record collections. Other topics discussed were the status of approval of the Adjudicatory Hearings Retention Schedule, priorities for the NRC Records Program, and potential areas of collaboration.
