Callaway nuclear power plant has been the subject of a number of petitions and press reports alleging or suggesting compromised safety culture at the facility. The settlement agreements in the request, if exist, could help clarify the allegations. In the wake of the Fukushima accident in Japan, the public attention has been trained on nuclear safety, and safety culture is a crucial component of plant safety. It is important to have questions about a nuclear plant's safety culture as well as the government's actions towards safeguarding it answered and explained to the public at the earliest possible opportunity. As I am making this request as a journalist and this information is of timely value, I would appreciate your communicating with me by telephone, rather than by mail, if you have questions regarding this request. Please provide expedited processing of this request which concerns a matter of urgency. As a journalist, I am primarily engaged in disseminating information.
