Subject: RAI concerning Ana Barlucea-Bajo, M.D.

In the letter dated 11/9/2011, NuScan requested the addition of Ana Barlucea-Bajo, M.D. for the use of 35.100, 35.200, and 35.300 materials. A preceptor form was provided as documentation of training and experience. However, the NRC Form 313(AUD) and (AUT) were not filled out correctly. On February 17, 2012, I contacted Dr. Hiram Rivera Luna, NuScan Owner and RSO to discuss the deficiencies. The 313(AUD) and (AUT) forms show that Dr. Barlucea-Bajo's Nuclear Medicine residency program lasted only two months???. I requested that Dr. Rivera check the dates of residency. In addition, the (AUT) form requested the authorization include all of 35.300, however, Dr. Barlucea-Bajo only shows casework with iodine-131. Therefore, Dr. Barlucea-Bajo will be authorized for the use of I-131 only. Finally, I reviewed the preceptor forms with Dr. Rivera and expect him to provide revised preceptor forms in the near future.

In addition, the preceptor forms were signed by Frieda Silva, M.D. and the licensee did not provide documentation showing that Dr. Silva is an authorized user (AU) for 35.100; 35.200; and 35.300 materials. A review of ADAMS showed that Dr. Silva is an AU on multiple licenses in Puerto Rico and she has acted as the preceptor on multiple preceptor forms.
