OI SYNOPSIS

This investigation was initiated on February 22, 2011, by the U.S. Nuclear Regulatory Commission, Office of Investigations, Region III, to determine whether a Planner at the Prairie Island Nuclear Plant was discriminated against for raising safety concerns.

Based upon the evidence developed, this investigation did not substantiate the allegation that a Planner was discriminated against for raising safety concerns.
