I had previously requested on February 1, 2012 that Dr. Smith submit documentation to show experience with eluting generator systems appropriate for the preparation of radioactive drugs for imaging and localization studies, measuring and testing the eluate for radionuclidic purity, and processing the eluate with reagent kits to prepare labeled radioactive drugs. On his original NRC Form 313A (AUD), the form indicated that generator training was not applicable because there was no generator use on site. On February 10, 2012, Ms. Houser submitted a revised NRC Form 313A (AUD) for Dr. Smith showing he had generator experience at his 80 Hour Nuclear Licensing Course for Physicians provided by Associates in Medical Physics, LLC. When I spoke with Ms. Houser, she said that Dr. Smith had one-day of generator training on September 25, 2008 at General Electric Radiopharmacy during the course. When Dr. Smith originally filled out the form, he thought he didn't have to submit the generator training because they did not use generators at their facility. I reviewed the Course Syllabus submitted by another licensee in ADAMS (ML110460157) and noted that the course did include generator training under Part VI of the syllabus. I also confirmed that Dr. Richard Smith is Dr. Richard L. Smith II.
