#### ORDER

The Southern Alliance for Clean Energy, Blue Ridge Environmental Defense League,
Center for a Sustainable Coast, Citizens Allied for Safe Energy, and Georgia Women's Action
for New Directions (collectively, Petitioners) filed a twenty-page motion for a stay of the
Commission's decision<sup>1</sup> authorizing issuance of combined licenses to construct and operate two
new nuclear power reactors at Southern Nuclear Operating Company's (Southern) Vogtle
Electric Generating Plant site.<sup>2</sup>

Southern requests that the Commission strike Petitioners' stay motion on the dual grounds that it exceeded (by ten pages) the page limit for such filings, and that Petitioners failed to seek an expansion of that page limit.<sup>3</sup> Alternatively, Southern seeks a similar expansion of the ten-page limit for its answer, to twenty pages.<sup>4</sup> The Staff states that it does not oppose

Southern's request for a page expansion, provided that the Staff is accorded the same expansion.<sup>5</sup>

Pursuant to my authority under 10 C.F.R. § 2.346(j), I grant Southern's and the Staff's requests for a ten-page expansion, to twenty pages (exclusive of affidavits), for their answers to Petitioners' stay motion. The Commission will address Southern's motion to strike in a separate decision.
