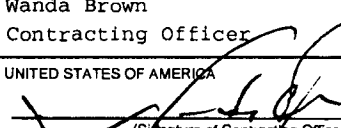

Accordingly, the following section is hereby revised:

Section 4.0 FUNDING, the first sentence of paragraph (b) is revised to read as follows:

(b) The amount presently obligated with respect to this task order is \$200,000.00. "The obligated amount shall, at no time, exceed the task order ceiling. When and if the amount(s) paid and payable to the contractor hereunder shall equal the obligated amount, contractor is not obligated to continue performance under this task order or otherwise incur costs in excess of the amount obligated, until the Contracting Officer notifies the contractor in writing that the obligated amount has been increased. In absence of such notification by the Contracting Officer, the Government is not obligated to reimburse the contractor for any costs in excess of the obligated amount specified therein. Any work undertaken by the contractor in excess of the obligated amount specified above is done so at the contractor's risk."
