Southern Nuclear Operating Company (SNC) is pleased to announce executive management changes to the Vogtle Electric Generating Plant (VEGP) Units 3 and 4 Project team.

Mr. Pete Ivey has been named Vice President of Regulatory Affairs for Southern Nuclear. He will be responsible for:

- Licensing and interface activities with the Nuclear Regulatory Commission for the fleet, including Vogtle 3 and 4.
- Interaction with the Georgia Public Service Commission on the hearings related to Vogtle 3 and 4.

Mr. Pete Ivey will be a member of the Southern Nuclear Management Council and will report to the Chairman, President & CEO of Southern Nuclear Operating Company.

Mr. Mark Rauckhorst has been named Vice President of Vogtle 3 and 4 Construction. He will be the lead for Southern Nuclear at the Vogtle 3 and 4 site and the principal interface with the Shaw and Westinghouse Site Directors. Mr. Mark Rauckhorst will report to the Executive Vice President of Nuclear Development.

MOO6 DO92 NRO Mr. David Jones has been named Vice President of Vogtle 3 and 4 Regulatory Affairs. He will be supporting Vogtle 3 and 4 licensing, compliance, ITAAC, and corrective action program activities required during construction. Mr. David Jones will be providing support and interface with the Vice President of Vogtle 3 and 4 Construction as a member of Vogtle 3 and 4 leadership team. Mr. David Jones reports to the Vice President of Regulatory Affairs for Southern Nuclear.

Mr. David McKinney has been named Vice President of Vogtle 3 and 4 Construction Support. He will be responsible for commercial activity, cost controls, governance, and reporting. Mr. David McKinney will also be supporting Georgia Public Service Commission hearings related to Vogtle 3 and 4 and will report to the Executive Vice President of Nuclear Development.

Mr. Randy Johnson has been named Vice President of Vogtle 3 and 4 Operational Readiness. He will be responsible for operating plant staffing, training, and start-up. Mr. Randy Johnson will report to the Executive Vice President of Nuclear Development.

Mr. Pete Ivey, Mr. Mark Rauckhorst, Mr. David Jones, Mr. David McKinney, and Mr. Randy Johnson assumed the new executive management positions on December 24, 2011.

The new executive management positions affect the organizational descriptions provided in the VEGP Units 3 and 4 Final Safety Analysis Report (FSAR) contained in the Combined License (COL) application and the Nuclear Development Quality Assurance Manual (NDQAM). Changes to the affected FSAR organizational descriptions will be incorporated in a future FSAR update. The changes to the active NDQAM are being processed in accordance with 10 CFR 50.55(f) in support of VEGP units 3 and 4.
