The purpose of this contract modification is to exercise option period/year three in accordance with FAR Clause 52.217-9, OPTION TO EXTEND THE TERM OF THE CONTRACT, thereby extending the period of performance through March 11, 2013 and increasing the contract ceiling by \$3,596,302.76 from \$12,962,941.92 to \$16,559,244.68. Accordingly, the contract is hereby modified as follows:

1) Under Section B.3 CONSIDERATION AND OBLIGATION- TASK ORDERS (AUG 1989) ALTERNATE 1 (JUN 1991), Paragraph (a) is revised to read as follows:

“(a) The Maximum Ordering Limitation (MOL) for products and services ordered, delivered, and accepted under this contract is \$16,559,244.68.”

2) Section F.7 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988) is deleted in its entirety and replaced with the following:

“The ordering period for this contract shall commence on March 12, 2008 and will expire on March 11, 2013. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-19 Ordering)”

All other terms and conditions of this contract remain unchanged.

This modification does not obligate any funds.
