Dennis,

It is currently Luminant's intent to reconcile the Comanche Peak design with the updated standard plant model and analyses. I believe this is what Mr. Valentin is referring to when he says "reconciliation analysis." This is a key part of the Integrated Seismic Closure Plan (ISCP) which we intend to provide by 4/16/12. The plan is intended to address the technical methodology and approach for reconciliation including how we intend to address the SASSI subtraction methodology if used. There is a possibility that the plan will not include the use of the subtraction method but we do not currently know that for sure. If used, we will discuss how and when we intend to produce a sensitivity study. As you know, we intend to request a public meeting in the May 2012 time frame to discuss these details with the reviewers.
