Nevertheless, the dataset was used to prepare licensee contact information associated with the subject SECY paper, and you, Point Beach, and Seabrook were affected by this error. (St. Lucie and Turkey Point were not.)

I have (1) notified the branch that is listed as point of contact for the affected information; (2) Cc'd the other affected Project Managers; and (3) contacted a Project Manager working on the Japan Lessons Learned activity concerned with the SECY paper. For any SECY-related correspondence that is directed through me, I will look for the correct information.
