A copy of the *Federal Register* notice of a proposed rulemaking, Revision of Fee Schedules; Fee Recovery for Fiscal Year (FY) 2012 is enclosed. The notice describes the U.S. Nuclear Regulatory Commission's proposed amendments to the licensing, inspection and annual fees charged to its applicants and licensees.

It is requested that the Office of Federal and State Materials and Environmental Management Programs notify the Agreement States to distribute this proposed rule to their licensees. The rule does not change the Title 10 of the *Code of Federal Regulations* (10 CFR) part 170 fees currently assessed to those Agreement State licensees who perform work in non-Agreement States under the reciprocity provisions of 10 CFR 150.20. The reciprocity fee would be \$2,300 under the FY 2012 proposed rule, the same as for FY 2011.
