This letter confirms the correspondence between Mr. Scott Murray of your staff and Ms. Nicole Coovert of this office on February 8, 2012, concerning a pre-decisional enforcement conference. This conference is being conducted at your request, and is scheduled for April 4, 2012, at 10:00 a.m. (EST). The purpose of the conference is to discuss the apparent violation associated with the significant delay in the Criticality Warning Systems (CWS) to initiate an immediate evacuation of the facility from May 2011 to July 17, 2011. The apparent violation was documented in NRC Inspection Report No. 70-1113/2011-005. The location of the conference will be at the NRC Region II Office, Marquis One Tower, 245 Peachtree Center Avenue, N.E., Suite 1200, Atlanta, Georgia 30303. This will be a Category 1 meeting in which the public is invited to observe. Members of the public will have the opportunity to communicate with the NRC staff after the business portion, but before the conference is adjourned, as per the NRC policy statement, "Enhancing Public Participation in NRC Meetings," published in the Federal Register: May 28, 2002 (Volume 67, Number 102, Page 36920-36924).
