Advanced Prognostics and Diagnostics

On May 11, 2012, as a result of a competitive negotiated acquisition, a cost plus fixed fee type contract (NRC-HQ-12-C-04-0062) was awarded to Sohar Incorporated of Culver City, CA. The contractor will provide technical guidance, regulatory-based acceptance criteria, and recommendations for tools and methodologies to support regulatory evaluation of proposed applications of Advanced Diagnostics and Prognostics. The contractor will also provide assistance to NRC staff in preparing review processes and inspection procedures. The period of performance is from May 11, 2012, to November 10, 2013, with no option periods. The total value of the contract is \$360,416.

Requirement for Fingerprint-Based Criminal History Records Checks for Individuals Seeking Unescorted Access to Non-Power Reactors (Research or Test Reactors), Final Rule; 10 CFR Part 73 (RIN 3150-Al25; NRC 2008-0619)

On May 11, 2012, the NRC published a final rule in the *Federal Register* (77 FR 27561) amending its regulations to require non-power reactor licensees to obtain fingerprint-based criminal history records checks before granting any individual unescorted access to their facilities. This action complies with the requirements of Section 652 of the Energy Policy Act of 2005 (EPAct), which amended Section 149 of the Atomic Energy Act of 1954, as amended, to require fingerprinting and a Federal Bureau of Investigation identification and criminal history records checks of individuals permitted unescorted access to a utilization facility. This rule will be effective on November 7, 2012.

<u>Filing a Renewed License Application, Denial of Petition for Rulemaking; 10 CFR Part 54</u> (Docket No. PRM-54-6; NRC 2010-0291)

On May 14, 2012, the NRC published a document in the *Federal Register* (77 FR 28316) denying a petition for rulemaking (PRM) submitted by Raymond Shadis and Mary Lampert on behalf of Earth Day Commitment/Friends of the Coast, Beyond Nuclear, Seacoast Anti-Pollution League, C-10 Research and Education Foundation, Pilgrim Watch, and New England Coalition, and joined in by New Hampshire State Representative Robin Reed (the petitioners). The petitioners requested that the NRC amend its regulations to accept a license renewal application (LRA) to sooner than 10 years before the expiration of the current license and to apply the revised rule to all LRAs for which the NRC has not issued a final safety evaluation report. The petitioners also requested a suspension of all new license renewal activity until the rulemaking is decided.

Office of Nuclear Reactor Regulation (NRR) Items of Interest Week Ending May 18, 2012

Waterford Steam Electric Station, National Fire Protection Association Standard No. 805 (NFPA 805), Regulatory Audit

During the week of May 7, 2012, the staff conducted an NFPA 805 regulatory audit at the Waterford Steam Electric Station, Unit 3. The audit team reviewed NFPA 805 transition documents related to Waterford's NFPA 805 license amendment request. Waterford's staff and their contractors conducted presentations, technical discussions, and plant tours to help the audit team understand the licensee's amendment request to transition to an NFPA 805 Fire Protection Program.

Public Meeting with Technical Specifications Task Force

On May 8, 2012, the staff conducted a quarterly Category 2 public meeting with the Technical Specifications Task Force (TSTF) to discuss a variety of technical issues and administrative processes related to Technical Specifications and TSTF Travelers (changes to the Standard Technical Specifications). The following items were discussed: issuance of STS Rev. 4, status of Travelers under review, TSTF concerns regarding NRC operating experience smart sample, technical specification interpretation and operability determination, status of NRC actions related to Surveillance Requirement 3.0.3 application to the In-Service Testing Program and other testing, status of a Traveler to revise the boiling water reactor operations with the potential to drain the reactor vessel, and changes to existing Section 3.0 of the STS because of resulting challenges with non-uniformity across licensees.

Final Rule on Fingerprinting at Non-Power Reactors

On Friday, May 11, 2012, the final rule on fingerprinting at Non-Power Reactors (NPRs) was published in the Federal Register. The final rule modifies 10 CFR 73.57 to require licensees to obtain FBI fingerprint-based criminal history records checks for all persons seeking or granted unescorted access to the licensees' vital areas or special nuclear material. Licensees have 180 days from the date of publication to implement the rule.
