## Office of Administration (ADM) Items of Interest Week Ending June 15, 2012

#### Advance Notification to Native American Tribes of Transportation of Certain Types of Nuclear Waste, Final Rule; 10 CFR Parts 71 and 73 (RIN 3150-AG41; NRC-1999-0005)

On June 11, 2012, the NRC published a final rule in the *Federal Register* (77 FR 34194) amending its regulations that govern packaging and transportation of radioactive material and physical protection of plants and materials. The amendments require licensees to provide advance notification to participating Federally-recognized Tribal governments regarding shipments of irradiated reactor fuel and certain nuclear wastes for any shipment that passes within their reservations. The rule extends relief to Tribal officials, designees, and Tribal law enforcement personnel from fingerprinting requirements required for access to Safeguards Information (SGI). The participating Tribal government is required to protect the shipment information as SGI. This final rule is effective on August 10, 2012. Compliance with the Tribal advance notification provisions of Title 10 of the Code of Federal Regulations 71.97(c)(3) and 73.37(f) is required on June 11, 2013.

# International Society of Automation Nuclear Standards Committee Meeting

On June 6 and 7, 2012, the NRC staff attended the annual International Society of Automation (ISA) SP67 Nuclear Standards Committee meetings held in Austin, TX, in conjunction with the 55th Annual Controls and Instrumentation Conference. The ISA SP67 Committee is responsible for development of American National Standards Institute (ANSI)/ISA S67 series nuclear plant engineering standards. During the meeting, NRC staff members provided a liaison report to the ISA Committee members regarding NRC staff work performed to update regulatory guides, interim staff guidance, proposed rulemaking, generic communications, and other regulatory documents associated with controls and instrumentation issues, including regulatory issues evolving from the March 2011 Fukushima Daiichi earthguake/tsunami event and the August 2011 North Anna earthquake event. Staff members were briefed by other members of the ISA Standards Committees regarding ongoing development of instrumentationrelated Institute of Electrical and Electronics Engineers, International Electrotechnical Commission, and ANS standards, as well as maintenance/obsolescence planning activities performed by the Pressurized Water Reactor Owners Group, and instrumentation research performed by Electric Power Research Institute (EPRI) and other organizations. Suggestions for updates to several ANSI/ISA standards were considered by the committee members to bring the standards up to date for use in new reactor construction activities.

# Seabrook Station, Unit 1, License Renewal Safety Evaluation Report with Open Items

On June 8, 2012, the staff issued the Safety Evaluation Report (SER) with Open Items related to the Seabrook Station, Unit 1 (Seabrook) license renewal application. By letter dated May 25, 2010, NextEra Energy Seabrook, LLC, submitted an application requesting the extension of the Seabrook operating license for an additional 20 years. The SER contains seven open items related to: (a) concrete degradation due to alkali-silica reaction; (b) the procedures and inspection requirements to keep the annular space between the containment and containment enclosure buildings dewatered; (c) the evaluation of future operating experience to ensure that the aging management programs will remain effective for managing the effects of aging during the period of extended operation; (d) the aging management of pressure-retaining bolting surrounded by seal cap enclosures; (e) the aging management of stainless steel components exposed to treated borated water; (f) the analysis of pressure-temperature limits; and (g) the aging management of primary water stress corrosion cracking on the primary coolant side of steam generator tube-to-tubesheet welds. The staff is scheduled to meet with the Advisory Committee on Reactor Safeguards Subcommittee on July 10, 2012, to discuss the Seabrook SER with Open Items.

#### Site Visit to Arkansas Nuclear One

On June 12 and 13, 2012, the staff held a public meeting at Arkansas Nuclear One (ANO) with Entergy to discuss their license amendment request (LAR) to transition Unit 2 to 10 CFR 50.48(c) (National Fire Protection Association (NFPA) 805). The staff identified four major LAR issues and decided to not accept the request, but give the licensee an opportunity to supplement the request by July 11, 2012. At the public meeting, the licensee presented a path forward to supplement the identified issues and provided the staff a site tour of their facility. The

staff discussed what an adequate supplement would contain, and the licensee has requested another public meeting, for June 27, to discuss their progress for meeting the July 11, 2012, deadline.

# Students Start Summer Internship with NRR

On June 13, 2012, three local high school students began a voluntary summer internships with NRR. They will develop a project to communicate the Probabilistic Risk Assessment (PRA) concept to the general public. The students will come to NRC once a week to meet with their mentors. The Office of Public Affairs will also provide guidance on public communication. This high school student voluntary program will promote science education in the local community and allow for career exploration early in the students' academic studies. This is a pilot program supported by the Office of the Chief Human Capital Officer.
