Revision of Fee Schedules; Fee Recovery for Fiscal Year 2012, Final Rule; 10 CFR Parts 170 and 171 (RIN 3150-AJ03; NRC-2011-0207)

On June 15, 2012, the NRC published a final rule in the *Federal Register* (77 FR 35809) amending the licensing, inspection, and annual fees charged to its applicants and licensees. The amendments are necessary to implement the Omnibus Budget Reconciliation Act of 1990, as amended, which requires the NRC to recover through fees approximately 90 percent of its budget authority in fiscal year (FY) 2012, not including amounts appropriated for Waste Incidental to Reprocessing and amounts appropriated for generic homeland security activities. Based on the Consolidated Appropriations Act of 2012, signed by President Obama on December 23, 2011, the NRC's required fee recovery amount for the FY 2012 budget is \$1,038.1 million. After accounting for billing adjustments, the total amount to be billed as fees to licensees is \$901 million. This final rule is effective on August 14, 2012.

<u>Tracking Nuclear Material Subject to the US/EURATOM Agreement for Peaceful Nuclear</u> Cooperation

On June 21, 2012, staff from the Material Control and Account Branch met with the U.S. Department of Energy (DOE) to discuss the tracking of nuclear material within the European Atomic Energy Community (EURATOM). Several months ago, EURATOM posed several questions to DOE concerning the documentation and tracking of certain nuclear material. The NRC staff shared information concerning how the nuclear material produced through the irradiation of low-enriched uranium fuel elements is tracked by the U.S. and provided a recommendation to DOE on how to track the nuclear material produced through the irradiation of the mix-oxide fuel element. DOE staff will use this information in preparing a reply to the EURATOM questions.

RES Withdraws Regulatory Guide (RG) 7.3, "Procedures for Picking up and Receiving Packages of Radioactive Material"

On June 15, 2012, the staff published a *Federal Register* Notice (77 FR 36017) announcing the withdrawal of RG 7.3 titled "Procedures for Picking up and Receiving Packages of Radioactive Material." The RG provides guidance to licensees for making arrangements for receipt, pickup, and monitoring of packages containing radioactive material, and reporting when received packages show evidence of leakage or excessive radiation levels. The NRC is withdrawing RG 7.3 because the information contained in this RG has been incorporated into revision 1 of RG 7.7, "Administrative Guide for Verifying Compliance with Packaging Requirement for Shipment and Receipt of Radioactive Material." Revision 1 of RG 7.7 was finalized in March 2012 and announced in the *Federal Register* on March 28, 2012 (77 FR 18872).

RES Publication of Draft Regulatory Guide DG-1277, "Initial Test Program of Emergency Core Cooling Systems for Boiling-Water Reactors"

On June 15, 2012, the staff issued DG-1277, "Initial Test Program of Emergency Core Cooling Systems for Boiling-Water Reactors" to provide the public an opportunity to comment on proposed New Draft Regulatory Guide DG-1277. This guide describes methods that the NRC staff considers acceptable to implement Title 10 of the Code of Federal Regulations, Part 50, "Domestic Licensing of Production and Utilization Facilities" (10 CFR Part 50), Appendix A, "General Design Criteria for Nuclear Power Plants," with regard to initial testing features of ECCSs for boiling-water reactors (BWRs).
