SUBJECT: **Fleet-wide Employee Meetings per NRC Confirmatory Order**

Reference: 1. NRC letter dated January 26, 2012; William Dean to John Herron; "Confirmatory Order (Effective Immediately) and Notice of Violation; Investigation Reports 1-2009-041, 1-2010-019, and 1-2010-031; Inspection Report 05000333/2011009".

This communication serves to summarize our fleet-wide actions and approach to conducting employee meetings at each of our nuclear power plant sites. NRC issued the referenced Confirmatory Order (CO) and Notice of Violation for the events involving misconduct of a radiation protection technician at JAF in 2006 to 2009. Section V.B of the CO states:

"Entergy will prepare a case study about the event that formed the basis of the CO, highlighting the role of those who had the opportunity to detect, report, and prevent the misconduct, as well as on the actions of the individuals who engaged in the misconduct. The Site Vice President or General Manager for Plant Operations at each of Entergy's nine commercial nuclear power plants will present the case study during two station-wide meetings to ensure that both day and night shift personnel will have the opportunity to attend. Entergy will complete these presentations within 180 days of the date of the CO. Entergy will make this case study available for NRC review before conducting these station-wide meetings, and will notify the senior resident inspectors at each of the Entergy sites regarding the dates and time of these meetings at their respective sites."

The following is a status of actions to assure compliance with this CO requirement.

- A. The Case Study presentation materials (FSEM-ADM-JAFNRC-CONF) have been developed and are now posted in the eB library, for your review in preparation for the meetings at your respective sites. The presentation package consists of:
  - i. PowerPoint slides with instructor notes
  - ii. Case Study scenarios - student version with questions
  - iii. Case Study scenarios - instructor version with answers to questions

The file location in eB is: Training Documents -> Supervisor Training -> Lesson Plans

- B. Entergy will submit a letter to NRC on or about May 24, 2012 providing notification that the case study is available for their review prior to Entergy conducting the first employee meeting.
- C. The planned schedule for employee meetings is based on your responses to CR-JAF-2012-966, CAs 6 through 14 for your respective site. This memo serves to communicate the planned dates to the NRC Senior Resident Inspectors (SRI). I am directing the site Licensing Managers to keep the SRIs informed of the final planned dates and times for the meetings at your site. The CO deadline for completing these meetings is July 24, 2012.
