Assessing Existing Analytical Tools and Develop Recommendations - Supporting the Office of Research

On July 26, 2012, as a result of a competitive solicitation, a cost-reimbursable contract (NRC-HQ-12-C-04-0066) was awarded to Regents of the University of California, University of California San Diego School of Medicine of La Jolla, CA. The contract is for assessing existing analytical tools and developing recommendations on their appropriate use for calculating soil pressures and structural response of partially to fully embedded nuclear power plants under seismic loading conditions. The period of performance for this contract is July 27, 2012, to June 30, 2014, with one 2-year option period. The total cost of this contract is \$1,056,687, inclusive of the option period.

Workshop on Performance Assessments of Near-Surface Disposal Facilities; Features, Events, Processes Analysis, Scenario and Conceptual Model Development, and Code Selection; Public Meeting; 10 CFR Part 61 (RIN-3150-AI92; NRC-2011-0012)

On August 13, 2012, the U.S. Nuclear Regulatory Commission published a document in the *Federal Register* (77 FR 48107) announcing plans to conduct a public workshop on performance assessments of near-surface low-level radioactive waste (LLW) disposal facilities. The workshop has been developed to facilitate communication among Federal and state agencies, industry representatives, contractors, and members of the public on three aspects of a performance assessment: (1) features, events, and processes analysis; (2) the development of scenarios and conceptual models; and (3) the selection of computer codes. Information gathered from invited subject matter experts, stakeholders, and other interested members of the public will be used to improve guidance on performance assessments for near-surface disposal of LLW. The workshop will be held on August 29, 2012 and August 30, 2012, in Rockville, MD.

Controlled Unclassified Information (CUI)

On August 9, 2012, staff from the Information and Records Services Division attended a working group meeting at the Controlled Unclassified Information Office (CUIO), National Archives and Records Administration. The purpose of the meeting was to discuss Version 2 of the draft Safeguarding policy and discuss Version 2 of the draft Dissemination policy. Additionally, the CUIO staff presented its analysis of the agency data call results for recommended Decontrol policy, and introduced preliminary information regarding proposed Marking policy. Additional discussion took place regarding requests from the Department of Energy for CUI policy regarding Cloud Computing and from the Office of the Director for National Intelligence for policy regarding what metadata fields should be required for CUI documents. The next CUI Working Group meeting will take place on August 23, 2012.
