SUBJECT: NRC APPROVAL OF NAC INTERNATIONAL'S REQUEST FOR WITHHOLDING  
INFORMATION FROM PUBLIC DISCLOSURE FOR MODEL NUMBER NAC-  
LWT (TAC NO. L24678)

Dear Mr. Patko:

By letter dated September 4, 2012, NAC International (NAC) submitted information in the form of presentation slides to support a closed portion of a meeting to discuss an upcoming revision request for the Model No. NAC-LWT transportation package.

Your September 4, 2012, letter included a NAC affidavit, signed by George Carver, dated September 4, 2012 (an attachment to your letter). The NAC affidavit requested that the material, which is contained in the slides, another attachment to your letter, be withheld from public disclosure pursuant to Title 10 of the Code of Federal Regulations (10 CFR) Section 2.390.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure pursuant to 10 CFR 2.390 for the following reasons:

- (1) Information that discloses a process, method, or apparatus, including supporting data and analyses, where prevention of its use by competitors of NAC, without license from NAC, constitutes a competitive economic advantage over other companies.
- (2) Information that, if used by a competitor, would reduce their expenditure of resources or improve their competitive position in the design, manufacture, shipment, installation, assurance of quality or licensing of a similar product.
- (3) Information that reveals aspects of past, present, or future NAC customer-funded development plans and programs of potential commercial value to NAC.

We have reviewed your application and all the supporting information in accordance with the requirements of 10 CFR 2.390 and, on the basis of your statements, have determined that the submitted information sought to be withheld is proprietary commercial and should be withheld from public disclosure.
