SUBJECT: SUMMARY OF WEEKLY CONFERENCE CALL MEETING TO DISCUSS OPEN ITEMS

AND OUTSTANDING REQUESTS FOR ADDITIONAL INFORMATION RESPONSES RELATING TO DETROIT EDISON'S FERMI 3 COMBINED LICENSE APPLICATION

On Thursday, August 23, 2012, the U.S. Nuclear Regulatory Commission's (NRC) staff held a public conference call from 1:00 pm to 3:00 pm with members of Detroit Edison. The purpose of the conference call was to discuss the status of the remaining open items (OI) related to the Fermi 3 Combined License Application. A list of the agenda items, actions items discussed during the call and a list of attendees are below.

Agenda Items

- 1. Does DTE still plan to have their preliminary calc runs done by the end of this month (where they can at least verbally describe to us what the results look like)? The applicant has completed these calculations.
- 2. Status of RAI 77 CEUS analysis (due 8/24) what can the staff expect to see in the response The NRC staff received this RAI according to the schedule on 8/24. The applicant stated that from this analysis a new seismic source would have to analyzed and incorporated in their RAI 79 response.
- 3. Status of RAI 79 SSI analysis (due 9/7) what can the staff expect to see in the response This RAI is scheduled to be submitted on time to the NRC. However, the response will only contain a schedule in which the applicant will show the path that they will use to close this RAI.
- 4. Proposed dates for public meeting for SSI discussion with the NRC staff- The applicant has requested to have a public meeting with the NRC staff to discuss their approach to resolve RAI 79. At this point they are looking to have this meeting at the end of September.
