I am writing to express my support in favor of license renewal for the Indian Point nuclear power plant.

As the former mayor and longtime resident of the Village of Buchanan, I am acutely aware of the economic impact the plant has on this village, the region and the state in general.

Indian Point provides about 25% of NYC and Westchester County's electricity. Its more than 1,000 employees and hundreds of contractors spend money on gas, food, supplies, gifts, entertainment and a multitude of other items in the local community, providing immeasurable fiscal support for the region. The employees, many of whom live in Buchanan and nearby towns, receive an annual payroll of more than \$140 million.

The loss of this plant and its positive economic impact is almost immeasurable and would utterly devastate this region.

If I believed for one second the plant was unsafe I would not support its continued operation. I strongly encourage you to renew the license for Indian Point.
