
I live and work in the Hudson River Valley. I am writing to express my support for the relicensing of Indian Point Units 2 and 3 in Buchanan, NY. It is my understanding that the NRC is considering numerous issues in connection with the license renewal application, including the effect of relicensing on land values in the area near the plants.

I recently took a guided tour of Indian Point and was impressed by its robust security, technology, and commitment to jobs and alternative energy. Indian Point has approximately 1,100 employees and usually has, on average, another 200 contractors on site. The facility spends \$137 million in annual full-time employee payroll, pays \$75 million in annual property taxes and revenue sharing with the State of New York, and makes annual donations of roughly \$1.5 million to area charities. Furthermore, Indian Point supplies between 25% and 30% of the electricity for New York City and the lower Westchester County area—helping to maintain the reliability of the electric grid.

Indian Point's significant positive economic impact, its long-standing support of local nonprofit institutions, and its important contribution to grid reliability are factors that help maintain land values in the communities near the plant. Those values would surely decrease if the facility were closed. I encourage you to renew the license for Indian Point after you have completed the appropriate safety and environmental reviews.
