SUBJECT: ACCEPTANCE REVIEW OF SOUTH CAROLINA ELECTRIC & GAS REQUEST FOR LICENSE AMENDMENT (LAR 12-01) AND EXEMPTION FOR THE VIRGIL C. SUMMER NUCLEAR STATION UNITS 2 AND 3: ADDITIONAL ELECTRICAL PENETRATION ASSEMBLIES

Dear Mr. Clary:

By letter dated August 29, 2012 (Agencywide Access Documents and Management System (ADAMS) Accession No. ML12244A011), South Carolina Electric & Gas (SCE&G) submitted a request for a license amendment and an exemption for the Virgil C. Summer Nuclear Station Units 2 and 3. The proposed license amendment request would depart from the plant-specific Design Control Document (DCD) Tier 1 and Tier 2 material by adding four new non-Class 1E Electrical Penetration Assemblies.

SCE&G has also requested an exemption from the provisions of Title 10 of the *Code of Federal Regulations* (10 CFR) Part 52, Appendix D, Section III.B, "Design Certification Rule for the AP1000 Design, Scope and Contents," to allow a departure from the elements of the certification information in Tier 1 of the generic DCD.

The purpose of this letter is to provide the results of the U.S. Nuclear Regulatory Commission (NRC) staff's acceptance review of these requests. The acceptance review was performed to determine if there is sufficient technical information in scope and depth to allow the NRC staff to complete its detailed technical reviews. The acceptance review is also intended to identify whether the application has any readily apparent information insufficiencies in its characterization of the regulatory requirements or the licensing basis of the plant.

Consistent with Section 50.90 of the 10 CFR, an amendment to the license must fully describe the changes requested, and follow as far as applicable, the form prescribed for original applications. Section 52.79 of the 10 CFR addresses content of technical information required. This section stipulates that the submittal address the design and operating characteristics, unusual or novel design features, and principal safety considerations.
