## SUBJECT: WESTINGHOUSE COLUMBIA PLANT SITE EMERGENCY PLAN REVISION

Westinghouse Electric Company LLC (Westinghouse) herein provides a revised Site Emergency Plan, Revision 15, for the Columbia Fuel Fabrication Facility (CFFF). This revision consists of the page changes enclosed and is submitted in accordance with the requirements outlined in 10 CFR 70.32(i) and SNM-1107 Materials License Safety Condition S-2. This revision of the Site Emergency Plan was implemented September 14, 2012. The revision reflects the completion of the Uranium Hexafluoride (UF6) storage pad annex project recently installed within the Controlled Access Area (CAA).

The other changes reflected in this revision are the result of comment resolution from the Westinghouse annual review. The Hazardous Material Table (page 1-7) has been updated to include all UF6 cylinders potentially on the plant site. Previous revisions listed only those cylinders located in the Conversion Area which were considered the only cylinders potentially subject to release. All changes are noted with revision bars in the left hand margin of the document.

This page change revision does not decrease the effectiveness of the plan as the capabilities of the emergency response organization are maintained equivalent to that of the existing plan.
