3. Our air monitoring system which runs continuously(24hrs./day) includes 2 Dwyer Air Flow Gauges Model RMB-53D-55V, they will be calibrated annually, last completed 01/10/2012, using - Instrument: Dwyer Mass Flow Meter SN: G68867-1 (Calibrated 8/24/11)
4. We confirm that "you agree to affix the required labels to all "transport radiation shields" and each container used to hold the radioactive drugs (per item 10.11 of Appendix D, NUREG-1556, Vol. 13, Rev. 1). I have included samples for your review.
