SUBJECT: TRANSMITTAL OF: (1) SUPPLEMENT TO THE BASELINE CULTURAL AND PALEONTOLOGICAL RESOURCE SURVEY, (2) INDIRECT AREA OF POTENTIAL EFFECTS MAP, AND (3) DRAFT ETHNOGRAPHIC CONTEXT FOR THE ROSS *IN-SITU* URANIUM RECOVERY PROJECT

Dear Mr. Windy Boy Sr.:

By letter dated January 4, 2011 (Agencywide Documents Access and Management System [ADAMS] Accession No. ML110120055), Strata Energy, Inc. (Strata) submitted a source material license application to the U.S. Nuclear Regulatory Commission (NRC) for the proposed Ross *In-Situ* Uranium Recovery Project (Ross Project) to be located in Crook County, Wyoming. The NRC accepted the application for review in a letter to Strata dated June 28, 2011 (ADAMS Accession No. ML111721948). After reviewing Strata's application, the NRC staff determined that additional information was required in order to complete its review. Therefore, by letter dated January 25, 2012 (ADAMS Accession No. ML113140576), the NRC provided Strata with Requests for Additional Information (RAIs) that identified the information needed for the continued review of Strata's license application.

By letter dated August 8, 2012 (ADAMS Accession No. ML12227A672), Strata provided a response to Environmental Report (ER) RAI Cultural-1(A), which requested additional information related to Strata's "2010 Baseline Cultural and Paleontological Resource Survey, Ross ISR Project Area" (Addendum 3.8-A to the ER). Enclosed with Strata's August 8, 2012 letter was Strata's "Supplement to the Environmental Report, Addendum 3.8-A National Register of Historic Places Evaluation: Testing of Selected Sites at the Proposed Ross ISR project, Crook County, Wyoming." The NRC is enclosing a copy of this supplement for your review and comment. By letter dated August 27, 2012 (ADAMS Accession No. ML12249A188), Strata also provided a "Draft Supplemental Map 'Indirect Area of Potential Effects (APE)' Analysis." This map depicts the prehistoric sites on record within three (3) miles of the Ross Project boundary. The NRC is also enclosing with this letter the map for your review and comment. As a reminder, the Supplement to Addendum 3.8-A and the Indirect APE Analysis Map are sensitive, and the NRC requests the proper storage of these documents, consistent with applicable laws and regulations pertaining to sensitive information.
