Mr. Mullett has worked in the nuclear power industry for over 30 years, specializing in radiation protection. Much of that time was spent as a Radiation Protection Technician working at Yankee Atomic, in Rowe, MA, and at Vermont Yankee, located in Vernon, VT. He has also performed work as a contracted Radiation Protection Technician and RP supervisor at various other power plants within the United States.

In addition to his power plant work, Mr. Mullett holds an Associate's Degree in Radiologic Technology and spent two years in the medical field as an X-ray Technician. For the past 2 ½ years, Mr. Mullett has been working at R.O.V. Technologies, Inc. as a Senior Radiation Protection Technician providing in-house RP guidance to employees.
