As discussed in the State of New York's ("NYS") letter dated September 14, 2012, Entergy and NYS have resolved an issue concerning the confidential and proprietary designation of four exhibits submitted in connection with Contentions NYS-6 and NYS-7. In March 2012, four documents, Entergy Exhibits ENT000233, ENT000238, ENT000253, and ENT000256, had been designated as containing proprietary material and withheld from the public. Following consultations, the parties have agreed to the following:

- ENT000233, Testimony Of Entergy Witnesses Alan B. Cox, Roger B. Rucker, Thomas S. Mccaffrey, And Howard G. Sedding Concerning Contentions NYS-6/NYS-7 (Non-EQ Inaccessible Medium- And Low-Voltage Cables) – The proprietary designation has been removed from this exhibit and it has been designated ENTR00233. The Exhibit is otherwise identical to what was filed on March 29, 2012.
- ENT000238, EPRI Report 10210701 Medium-Voltage Cable Aging Management Guide This exhibit will retain its proprietary designation.
- ENT000253, IEEEP400.3-2006, IEEE Guide for Partial Discharge Testing of Shielded Power Cable Systems in a Field Environment The proprietary designation has been

removed from this exhibit, a copyright banner has been added, and it has been designated ENTR00253. The Exhibit is otherwise identical to what was filed on March 29, 2012.

• ENT000256, IEEE 400.2-2004, IEEE Guide for Field Testing of Shielded Power Cable Systems Using Very Low Frequency – The proprietary designation has been removed from this exhibit, a copyright banner has been added, and it has been designated ENTR00253. The Exhibit is otherwise identical to what was filed on March 29, 2012.

The parties anticipate that they will be able to resolve any confidentiality concerns with respect to this ENT000238 on an as needed basis during the hearing. As such, the evidentiary hearing on NYS-6 and NYS-7 may be open to the public.

Entergy is also submitting a revised version of ENT000137, Village of Buchanan, Comprehensive Master Plan (Mar. 2005), as the previously filed excerpt lacked three necessary pages. The complete version of this document was disclosed to all parties in December 2011. The Exhibit is otherwise identical to what was filed on March 28, 2012.

Finally, pursuant to Law Clerk Ms. Lewman's email of September 20, 2012, Entergy also submits a revised exhibit list (ENTR40001), which reflects all of the changes discussed above. Please note that a possible motion to admit additional exhibits may necessitate further edits to this list.
