Speech Enhancement Services

On September 19, 2012, as a result of a small business set-aside competitive solicitation, a firm-fixed-price contract (NRC-HQ-12-C-38-0098) was awarded to Speech Potential Associates of Gaithersburg, MD. This contract will provide speech pathology services as it relates to accent reduction, accent modification, and English for Speakers of other Languages. The period of performance is September 28, 2012 to September 27, 2013, with four 1-year option periods. The total cost is \$628,716, inclusive of all options.

Small Business Technical Support Services

On September 24, 2012, as a result of a non-competitive 8(a) solicitation, a labor-hour contract (NRC-HQ-12-C-27-0120) was awarded to CoreSphere, LLC. of Potomac, MD. The contractor will provide small business technical support services to the Office of Small Business and Civil Rights. Controlled Unclassified Information (CUI)

On October 4, 2012, staff from Information and Records Services Division attended a working group meeting at the Controlled Unclassified Information Office (CUIO), National Archives and Records Administration. Discussion continued on the proposed policy for safeguarding, dissemination, and decontrol of CUI, which the CUIO consolidated into one draft document. Whether "CUI Basic" should be encrypted in emails was also discussed. Although many agencies already encrypt sensitive emails, the consensus was that the level of effort, financial and technical resources, and complexity of requiring encryption was not worth the additional security to be gained, i.e., the risk of loss of CUI was not significant enough to justify the expense and changes to business practices. The CUIO agreed to write the policy so that it encourages encryption as a best practice but will not require it. This is a change from the initial proposal that all CUI would require encryption when emailed. After much discussion, the CUIO also stated that they will try to include reasonable details but does not reduce agency flexibilities in implementation. The next working group meeting will be on October 17, 2012.

Public Meeting on Financial Qualifications for Merchant Plants

On October 11, 2012, NRO and NRR hosted a category 3 public meeting to explore financial qualifications for merchant plant Combined License (COL) applicants. These plants are required to demonstrate financial qualification under 10 CFR 50.33(f) before a COL can be issued. Some industry stakeholders characterize this is a "chicken and egg" conundrum since they believe they cannot obtain financing until after the COL has been issued. Presentations were made by finance professionals and one merchant plant COL applicant – Nuclear Innovation North America, who has proposed a license condition to resolve the issue. Comments were received from other merchant plant applicants, potential small modular reactor applicants, and NEI. The industry view is that this issue is a generic one and that the NRC should take it up as a policy matter for resolution. The Nuclear Energy Institue has offered to propose options for consideration. The staff will be gathering additional information and conducting more outreach to inform resolution of this issue.

Meeting with South Texas Project Nuclear Operating Company

On October 10, 2012, representatives of South Texas Project Nuclear Operating Company (STPNOC) and the staff met to discuss the licensee's risk-informed approach for resolving Generic Safety Issue No. 191 (GSI-191), "Assessment of Debris Accumulation on PWR [Pressurized-Water Reactor] Sump Performance," regarding South Texas Project, Units 1 and 2. This was the 15th pre-licensing meeting with the licensee regarding this matter.

Pre-licensing Meeting with South Texas Project Nuclear Operating Company

On October 11, 2012, representatives of STPNOC and the staff met to discuss the licensee's plans to submit an amendment request for approval of the revised fire protection program related to the alternate shutdown capability presently documented in the Fire Hazards Analysis for South Texas Project, Units 1 and 2.
