Web Development Assistance

On November 29, 2012, as a result of an 8(a) non-competitive solicitation, a time-and-materials task order (GS06F0684Z/NRC-HQ-13-F-38-0001) was awarded to Astor & Sanders Corporation of Rockville, MD, for web development assistance. The period of performance is December 3, 2012, to November 30, 2015, with one 1-year option period. The total cost of the task order is \$958,732.80, inclusive of all options.

Meta System Help Desk Services

On November 30, 2012, as a result of an 8(a) non-competitive solicitation, a firm-fixed-price task order (GS06F08992/NRC-HQ-13-T-33-0001) was awarded to Aqiwo, Inc., of Vienna, VA, for Meta System help desk services. The period of performance is December 1, 2012, to November 30, 2012, with six 1-year option periods. The total cost of the task order is \$3,165,253, inclusive of all options.

Technical Assistance Protest Update

On November 30, 2012, the NRC provided a response to the agency protest from three organizations (Energy Research, Inc., Information Systems Laboratories, Inc., and Numark Associates, Inc.) challenging NRC's award of contract number NRC-HQ-12-C-42-0057 to Southwest Research Institute for technical assistance activities related to small modular reactor license applications.

<u>Technical Corrections; Correction: Final Rule; Correcting Amendment; 10 CFR Part 171 (RIN 3150-AJ16; NRC-2012-0092)</u>

On December 5, 2012, the NRC published a final rule in the *Federal Register* (77 FR 72200) correcting a final rule that was published in the *Federal Register* on July 6, 2012, (77 FR 39899), and effective on August 6, 2012. This final rule amended NRC regulations to make technical corrections, including updating the street address for the Region I office, correcting authority citations and typographical and spelling errors, and making other edits and conforming changes. This amendment is necessary to correct the statutory authority that is cited in one of the authority citations in the final rule. The correction was effective on December 5, 2012.
