Revision of Fee Schedules; Fee Recovery for Fiscal Year 2013; Proposed Rule; 10 CFR Parts 170 and 171 (RIN 3150-AJ19; NRC-2012-0211)

On March 7, 2013, the NRC published a proposed rule in the *Federal Register* (78 FR 14880) to amend the licensing, inspection, and annual fees charged to its applicants and licensees. The proposed amendments were necessary to implement the Omnibus Budget Reconciliation Act of 1990, as amended, which requires the NRC to recover through fees approximately 90 percent of its budget authority in fiscal year (FY) 2013, not including amounts appropriated for Waste Incidental to Reprocessing, and amounts appropriated for generic homeland security activities. The NRC is currently operating under a Continuing Resolution (CR) which is set to expire on March 27, 2013. Based on the FY 2013 budget submitted to the Congress, the NRC is proposing fees in this rulemaking based on the FY 2013 budget which is estimated to be \$1,053.2 million. After accounting for billing adjustments, the total amount to be billed as fees is approximately \$924.8 million. These fees are subject to change pending congressional action, which may include sequestration, full-year CR or issuance of an FY 2013 appropriation which differs from the FY 2013 budget submitted to Congress, and could result in higher or lower fees than those proposed in the rulemaking. The comment period on the proposed rule closes on April 8, 2013.

Schedule letter issued to AREVA

On March 5, 2013, NRC staff notified AREVA, NP, Inc. (AREVA) of a change to the U.S. Evolutionary Power Reactor (EPR) Design Certification application public milestone schedule. The target date for the completion of the rulemaking has been changed from December 2014 to June 2015. The schedule change principally resulted from additional review effort needed in the areas of Fuel Seismic Mechanical Assembly and Seismic Margin analyses.

Letter issued for Turkey Point combined license application

On February 27, 2013, NRC staff issued a letter to Florida Power and Light Company suspending the alternative sites section of the environmental review for the Turkey Point Units 6 & 7 combined license application. The letter states that the NRC cannot complete its environmental impact statement until the technical issues related to the alternative sites are resolved, and that the environmental review schedule will continue to be delayed.

Schedule change issued for U.S. Advanced Pressurized Water Reactor (US-APWR) design certification review

On February 28, 2013, NRC staff notified Mitsubishi Heavy Industries (MHI) of a change to the US-APWR Design Certification application review schedule. The revision extends the Final Safety Evaluation Report schedule by six months, from March 2015 to September 2015, with a target date of February 2016 for completion of the rulemaking. The schedule change principally resulted from additional review effort associated with changes to both the plant configuration and the seismic analysis methodologies.

Geomagnetic Disturbance (GMD) Task Force Phase 2 Meeting

On February 25-27, 2013, staff attended a GMD Task Force Phase 2 meeting hosted by North American Electric Reliability Council (NERC) in Atlanta, GA. The purpose of the meeting was to discuss issues related to electric grid challenges as a result of GMD and degradation of large power transformers. During this meeting, the task force members discussed developing tools required for industry transmission system planners, preparing GMD mitigation strategies, developing guidance for transmission system operators to manage GMD impacts, strategies to promote education and information exchanges between researchers and industry, and enhancing NERC Reliability Standards. Industry experts from various utilities, electric equipment manufacturers, the Electric Power Research Institute, and various Universities that have experience with geo-magnetically induced current as a result of geomagnetic storms and solar flares participated and provided technical input. Federal entities such as the National Oceanic and Atmospheric Administration, U.S. Geological Survey, Department of Energy, and Federal Energy Regulatory Commission participated in this meeting.

Staff Meeting with Non-Destructive Examination Improvement Focus Group (NIFG)

On February 28, 2013, the staff met with industry personnel for the NIFG to discuss industry actions stemming from the North Anna non-destructive examination event in March 2012. At this meeting, the NIFG provided a status of actions taken. The staff provided comments on the site specific mockup guidance and the hands on practice guidance during the meeting.
