SUBJECT: BROWNS FERRY NUCLEAR PLANT, UNIT 1, 2, and 3 - REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE FOR TENNESSEE VALLEY AUTHORITY COMMITMENT RELATED TO CORE PLATE BOLT STRESS ANALYSIS (TAC NOS. ME6615, ME6616, AND ME6617)

Dear Mr. Shea:

By letter dated June 15, 2011, you submitted an affidavit dated December 15, 2010, executed by Edward D. Schroll of General Electric-Hitachi Nuclear Energy Americas LLC (GEH). It was requested that the information contained in NEDC-33632P, "Browns Ferry (Units 1-3) Core Plate Bolt Analysis Stress Analysis Report," Revision 0, dated December 2010 be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390.

A nonproprietary copy of this document has been placed in the U.S. Nuclear Regulatory Commission's (NRC's) Public Document Room and added to the Agencywide Documents Access and Management System Public Electronic Reading Room.

The affidavits stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- a. Information that discloses a process, method, or apparatus, including supporting data and analyses, where prevention of its use by GEH's competitors without license from GEH constitutes a competitive economic advantage over GEH and/or other companies.
- b. Information that, if used by a competitor, would reduce their expenditure of resources or improve their competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product.

By letter dated May 28, 2013, Tennessee Valley Authority (TVA) provided correction regarding the proprietary information in the Enclosure 1 (the above referenced document) of its letter dated June 15, 2011. TVA, in its letter dated May 28, 2013, stated that GEH has determined, in response to the NRC staff question, that the proprietary determination of a statement in Section 5.8 of Enclosure 1 was incorrectly marked as proprietary and can be considered nonproprietary.


