On March 26, 2013, as a result of a competitive negotiated acquisition, a firm-fixed priced contract (number NRC-HQ-13-C-04-0026) was awarded to Alden Research Laboratory, Inc., of Holden, Massachusetts. This contract is for the Computational Fluid Dynamics Modeling and Simulation Support for European Union Experimental Investigations on Reactor Containment, Thermal-Hydraulics, and Severe Accident Management Project.
