Office of Administration (ADM) Items of Interest Week Ending April 12, 2013

Architectural and Engineering and Interior Design Services

On April 5, 2013, as a result of a competitive acquisition, an indefinite delivery/indefinite quantity contract (NRC-HQ-13-C-10-0035) was awarded to Eighth Day Design, Inc., of Arlington, VA, for architectural and engineering and interior design services. The period of performance is from April 8, 2013, to April 7, 2014, with four 1-year option periods. The total value of the contract is \$900,000, inclusive of all options.

Potential Changes to Interlocutory Appeals Process for Adjudicatory Decisions: Advance Notice of Proposed Rulemaking; Request for Comment; 10 CFR Part 2 (RIN 3150-AJ24; NRC-2013-0050)

On April 5, 2013, the NRC published an Advance Notice of Proposed Rulemaking in the *Federal Register* (78 FR 20498), to begin the process of potentially amending its regulations to change the interlocutory appeals process for certain adjudicatory decisions. The NRC is considering four options pertaining to the interlocutory review of rulings on requests for hearings or petitions to intervene under section 2.311 of Title 10 of the Code of Federal Regulations (10 CFR). The NRC is seeking public comment on the four options. The comment period closes on July 5, 2013.

Station Blackout Mitigation Strategies: Draft Regulatory Basis and Draft Rule Concepts; Request for Comment; 10 CFR Parts 50 and 52 (RIN 3150-AJ08; NRC-2011-0299)

On April 10, 2013, the NRC published a draft regulatory basis document in the *Federal Register* (78 FR 21275), to support the potential amendment of its regulations concerning nuclear power plant licensees' station blackout mitigation strategies. The issuance of the document is one of the actions stemming from the NRC's lessons-learned efforts associated with the March 2011 Fukushima Dai-ichi nuclear power plant accident in Japan. The comment period closes on May 28, 2013.

<u>Installation of Radiation Alarms for Rooms Housing Neutron Sources; Petition for Rulemaking; Denial; 10 CFR Part 73 (PRM-73-15; NRC-2011-0251)</u>

On April 11, 2013, the NRC published a denial of a petition for rulemaking in the *Federal Register* (78 FR 21567) submitted by George Hamawy (the petitioner). The petitioner requested that the NRC amend its regulations to require the installation of radiation alarms for rooms housing neutron sources. The NRC received four comments, which all opposed the petition. After review of the petition and comments, the NRC has closed the docket for the petition, PRM-73-15.

<u>Public Meeting for License Renewal Process and Environmental Scoping for Sequoyah</u> Nuclear Plant

On April 3, 2013, the staff conducted two identical public meetings in Soddy Daisy, TN, to discuss the license renewal review process and to solicit public comments concerning the scope of the environmental review for the Sequoyah Nuclear Generation Station, Unit 1 and Unit 2 license renewal application. Approximately 25 people attended the afternoon meeting and 32 people attended the evening meeting, including the applicant, local residents, government officials, citizen organizations, and news media. Public comments included concerns regarding emergency preparedness, aging management, design safety, human health and radiological exposure, environmental impacts, radioactive waste storage and disposal, flooding, seismic, and other accidents similar to Fukushima. Public scoping comments are due by May 3, 2013.

<u>Brunswick Nuclear Plant, National Fire Protection Association Standard No. 805 (NFPA 805), Regulatory Audit</u>

During the week of April 8, 2013, the staff conducted an NFPA 805 regulatory audit at the Brunswick Nuclear Plant in Southport, NC. The audit team reviewed site NFPA 805 transition documents related to Brunswick's NFPA 805 license amendment request. The licensee's staff and their contractors conducted presentations, technical discussions, and plant tours to help the NRC audit team verify the details of their amendment request to transition to an NFPA 805 fire protection program.

Nuclear Decommissioning Funding Teleconference with UBS Investment Research

On April 5, 2013, the staff participated in a UBS Investment Research teleconference on the topic of decommissioning funding. During the teleconference, the staff explained NRC decommissioning funding assurance requirements and oversight responsibilities, and responded to questions from the participants. There were approximately 100 participants from industry, NEI, and financial institutions.

End-of-Cycle Summary Meeting

On April 1, 2013, the staff conducted the End-of-Cycle Summary Meeting. Meeting participants included Regional Administrators, NRR's Office and Deputy Office Directors, Office of Nuclear Security and Incident Response Director, Office of Enforcement Director, and supporting staff members from Headquarters and the Regions. Meeting participants discussed the results of the end-of-cycle meetings in each Region and potential Agency Action Review Meeting (AARM) and post-AARM topics.
