Revision to the Petition for Rulemaking Process; Proposed Rule; 10 CFR Part 2 (RIN 3150-Al30; NRC-2009-0044)

On May 3, 2013, the NRC published a proposed rule in the *Federal Register* (78 FR 25886) that proposes to amend its regulations to streamline its process for addressing petitions for rulemaking (PRM). The proposed amendments are intended to improve transparency and make the PRM process more efficient and effective. The comment period on the proposed rule closes on July 17, 2013.

Design Specific Review Standard for mPower Design Issued for Comment

During the week of May 6, 2013, the staff issued 154 sections of the mPower Design Specific Review Standard (DSRS) to the public via Agencywide Document Access and Management System (ADAMS) along with the mPower DSRS Scope and Safety Review Matrix (ADAMS Accession No. ML12305A348). The DSRS will provide staff guidance to perform the 10 CFR Part 52 reviews of the B&W mPowerTM design. The Scope and Safety Review Matrix addresses the applicability of all Standard Review Plan sections for mPower. In some cases, the section will be used as-is for the review, some sections don't apply to the review because the structure, system or component may not exist in this design, some sections needed editing to address unique features of mPower or to incorporate lessons learned from previous reviews, and some new sections were added. A *Federal Register* notice will be issued the week of May 13, 2013, to solicit comments on the Matrix and DSRS sections. Public comments will be due no later than August 16, 2013.

Technical Review group (TRG) Refresher Training

On May 2, 2013, the staff held annual refresher training for 45 members of the agency's Technical Review Group (TRG) program. Approximately 175 staff members from headquarters and the regions participate in TRGs. TRG members and leads are divided into 25 technical areas ranging from Auxiliary Feedwater and Electrical Power Systems to Safety Culture and Cyber Security. Each year, TRG leads work together with their members to combine operating experience information from numerous sources with their own expert knowledge and recommend and/or highlight agency actions in their areas of expertise. TRG recommendations are often incorporated into generic communications or revisions to the regional inspection programs.

Reactor Oversight Process First Quarter 2013 ROP Update

On May 6, 2013, the Reactor Oversight Process (ROP) plant assessment results for the 1st quarter of NRC fiscal year 2013 were posted on the NRC external website. The following plants returned to Column 1: Harris and Seabrook. Grand Gulf, Three Mile Island 1 and Turkey Point 3 transitioned to Column 2. The following plants remained in Column 2: Beaver Valley 1 and 2, Browns Ferry 3, Davis Besse, Fermi, Fitzpatrick, Kewaunee, Nine Mile Point 1, Point Beach 1, Prairie Island 1 and 2, and Susquehanna 2. Browns Ferry Unit 2 transitioned to Column 3. The following plants remained in Column 3: Columbia Generating Station, Perry, and Wolf Creek. Browns Ferry Unit 1 remained in Column 4, and Fort Calhoun remained under Inspection Manual Chapter 0350 oversight.

Presentation at Battcon Conference

On May 6 - 7, 2013, the staff participated in the 2013 Battcon Conference in Orlando, FL. The staff gave a presention titled "The Enhancements of NRC Station Blackout Requirements for Nuclear Power Plants." (ADAMS Accession Number ML13123A22) The purpose of the presentation was to inform the attendees of the NRC's Station Blackout Mitigating Strategies rulemaking effort in wake of the Fukushima event.
