Physical Protection of Irradiated Reactor Fuel in Transit: Final Rule; 10 CFR Part 73 (RIN 3150-Al64; NRC-2009-0163)

On May 20, 2013, the NRC published a final rule in the *Federal Register* (78 FR 29520) amending its security regulations for the transport of irradiated reactor fuel. This rulemaking established generically applicable security requirements similar to the requirements currently imposed by NRC Order EA-02-109, "Issuance of Order for Interim Safeguards and Security Compensatory Measures for the Transportation of Spent Nuclear Fuel Greater than 100 Grams." The rulemaking also establishes performance standards and objectives for the protection of spent nuclear fuel shipments from theft, diversion, or radiological sabotage. Additionally, this rulemaking addresses, in part, a 1999 petition for rulemaking (PRM) from the State of Nevada (PRM-73-10) that requested the NRC to strengthen the regulations governing the security of spent nuclear fuel shipments against malevolent acts. The rule will become effective on August 19, 2013.
