<u>Technical Assistance with the Production of Generic Aging Lessons Learned Report for</u> <u>Subsequent License Renewal</u>

On July 3, 2013, as a result of a sole source procurement, a cost plus fixed fee contract (NRC-HQ-13-C-03-0044) was awarded to South West Research Institute of San Antonio, TX. The objective of this contract is to assist with the production of a Generic Aging Lessons Learned report for subsequent license renewal. The period of performance is from July 8, 2013, to September 28, 2016, with two one-year option periods. The total value of the contract, including all options, is \$805,263.

Interim Enforcement Policy for Permanent Implant Brachytherapy Medical Event Reporting; Policy Statement; Revision (NRC-2013-0114)

On July 9, 2013, the NRC published a notice in the *Federal Register* (<u>78 FR 41125</u>) issuing an interim Enforcement Policy that allows the staff to exercise enforcement discretion for certain violations of regulations for reporting medical events occurring under an NRC licensee's permanent implant brachytherapy program. This interim policy affects NRC licensees that are authorized to perform permanent implant brachytherapy. This policy revision was effective July 9, 2013.

<u>CampCo Petition to Allow Commercial Distribution of Tritium Markers; Petition for Rulemaking;</u> <u>Notice of Receipt and Request for Comment; 10 CFR Part 32 (PRM-32-8; NRC-2013-0078)</u> On July 11, 2013, the NRC published a notice of receipt and request for comment for a petition for rulemaking (PRM) in the *Federal Register* (<u>78 FR 41720</u>). The PRM was filed by CampCo (the petitioner) on December 2, 2011 and supplemented on September 18, 2012. The PRM was assigned Docket No. PRM-32-8. The petitioner requests that the NRC amend its regulations to allow the commercial distribution of tritium markers for use under exemption from licensing requirements. Public comments are due by September 24, 2013.

Medical Isotope Production

On July 1, 2013, staff published two *Federal Register* notices (78 FR 39342 and 78 FR 39343) related to the review of the construction permit application for SHINE Medical Technologies, Inc. (SHINE). The first notice announced the acceptability for docketing of part one of the two-part construction permit application. The second notice announced the NRC's intent to prepare an environmental impact statement in support of the review of the SHINE application. There is a 60-day comment period for the latter notice, closing on August 30th. Both notices may be accessed at <u>http://www.regulations.gov</u> under Docket ID "NRC-2013-0053."

Office of Nuclear Regulatory Research (RES) Items of Interest Week Ending July 12, 2013

Publication of Regulatory Guide 1.124, "Service Limits and Loading Combinations for Class 1 Linear-Type Supports," and Regulatory Guide 1.130, "Service Limits and Loading Combinations for Class 1 Plate-and-Shell-Type Supports."

On July 8, 2013, the staff announced in the *Federal Register* the availability of Regulatory Guide (RG) 1.124, Revision 3, "Service Limits and Loading Combinations for Class 1 Linear-Type Supports," and RG 1.130, Revision 3, "Service Limits and Loading Combinations for Class 1 Plate-and-Shell-Type Supports," (78 FR 40776). Revision 3 of RG 1.124 and Revision 3 of RG 1.130 were issued under the administrative change process because the changes between Revision 2 and Revision 3 are non-substantive. The noteworthy change in Revision 3 of both RGs is the acceptance for use of the 2007 Edition through the 2008 Addenda of the Boiler and Pressure Vessel Code (American Society of Mechanical Engineers B&PV Code), Section III, Division 1.
