I am writing to appeal a recent filing for a request to receive documents related to the Fukushima Nuclear Crisis in Japan.

My FOIA/PA identification number is: 2013-0088

The request I made was for correspondence *and* documents between Admiral Kirkland Donald, Troy Mueller and Charles Casto. (see attached document).

The response I received on June 18, 2013 indicated that:

Certain Information in the requested records is being withheld from disclosure pursuant to:

- 1. Exemption 5 (deliberative process)
- 2. Exemption 6 (invasion of personal privacy)

My appeal is that while some of the information conveyed might be personal in nature and that others may have been part of a deliberative process, these individuals were representatives of federal agencies (Naval Reactors and NRC) and some of their communications would have been also shared with many parties in U.S. government organizations and thus were not private in nature.

Moreover, in addition to emails, I requested briefing documents and powerpoint documents, that would have been summary documents *after* the deliberative process had been completed.

As is indicated in the NRC phone transcripts that were made available via FOIA, these parties communicated across a range of media, not limited to emails and the emails were not all private in nature. Their content reflects the end result of decision making of entire organizations, with multiple parties cc'd in, as situation reports, daily briefings, and summary documents. These are not personal emails.

While I do appreciate that some of the information contained herein may have been personal, and may have involved decision making processes, to provide absolutely no information whatsoever from these parties seems unreasonable and dismissive. The document I was directed to - an email exchange between Mueller and Casto opens with "these are my thoughts" followed by two pages of redacted information (blanked out) and then a sign-off. No substantive information whatsover except an indication that they were communicating.

In the month between March 11 and April 11, there would have been many communications between these parties. To characterize all of these communications to be either personal or part of a deliberative process is not reasonable.

I respectively request that you revisit this request, and excluding those emails that you allude to in your response to my initial request (if necessary), that you make available attached documents and communications that do not fall under these criteria. Basically, this is not all or nothing - there must be communications between these parties that does not fall under these restrictions.

Thank you for the consideration. I appreciate your response to my inquiries and for your review of this appeal.
