## Physical Protection of Irradiated Reactor Fuel in Transit: Orders; Rescission; 10 CFR Part 73 (RIN 3150-Al64; NRC-2009-0163)

On August 19, 2013, the U.S. Nuclear Regulatory Commission (NRC) published a document in the *Federal Register* (78 FR 50313) rescinding EA-02-109, "Issuance of Order for Interim Safeguards and Security Compensatory Measures for the Transportation of Spent Nuclear Fuel [SNF] greater than 100 Grams," dated October 10, 2002, and subsequent similar security orders issued to licensees shipping SNF during the period of October 2003 through December 2010. These orders are collectively referred to as the "SNF Transportation Orders." The SNF Transportation Orders are being rescinded because the NRC published a final rule, "Physical Protection of Irradiated Fuel in Transit," on May 20, 2013 (78 FR 29520), amending its regulations to incorporate the security requirements in the SNF Transportation Orders and lessons learned from implementation of the SNF Transportation Orders. This rescission was effective on August 19, 2013.

#### <u>Public Meetings for License Renewal Process and Environmental Scoping for Byron</u> Station, Units 1 and 2, and Braidwood Station, Units 1 and 2

On August 20, 2013, staff conducted two identical public meetings in Byron, IL, to discuss the license renewal review process and to solicit public comments concerning the scope of the environmental review for the Byron Station, Units 1 and 2, license renewal process. Approximately 30 members of the public attended each meeting, including a staffer from Illinois Congressman Adam Kinzinger's office. During the meetings, staff received about 23 public scoping comments from members of the public. On August 21, 2013, staff conducted two identical public meetings in Braidwood, IL, to discuss the license renewal review process and to solicit public comments concerning the scope of the environmental review for the Braidwood Station, Units 1 and 2, license renewal process. Approximately 30-40 members of the public attended the two meetings, including State Senator Sue Rezin and a staffer from Illinois Congressman Adam Kinzinger's office. During the meetings, staff received about 30 public scoping comments from members of the public on a variety of topics, including concerns about past tritium leaks and subsequent remediation at Braidwood. Public scoping comments for both the Byron and Braidwood license renewal reviews are due by September 27.

# Office of Federal and State Materials and Environmental Management Programs (FSME) ltems of Interest Week Ending August 23, 2013

#### New Mexico Meetings Associated with the HMC Decommissioning Site

On August 13-14, 2013, staff from the Office of Federal and State Materials and Environmental Management Programs (FSME) traveled to New Mexico (NM) to conduct a number of meetings associated with the Homestake Mining Company of California (HMC) decommissioning site in Milan, NM. FSME staff and management met with Environmental Protection Agency (EPA) Region 6, to discuss the regulatory path forward for decommissioning activities at the site. Staff from FSME's Division of Waste Management and Environmental Protection participated in an Executive Steering Committee meeting to discuss ongoing decommissioning activities. The Nuclear Regulatory Commission (NRC) and EPA agreed to continue ongoing remediation activities. However, it was also agreed that NRC should explore the possibility of deferring regulatory authority for remediation activities to EPA.

In addition, FSME staff met with the Navajo Nation in Gallup, NM, and the Acoma and Laguna Pueblos in Acoma, NM, to discuss their concerns regarding legacy and future uranium mining and milling activities in New Mexico. NRC and EPA also held a joint public meeting in Grants, NM, to understand the public's concerns regarding ongoing groundwater reclamation activities at the HMC site.
