Office of Administration (ADM) Items of Interest Week Ending November 1, 2013

Onsite Emergency Response Capabilities; Regulatory Basis; 10 CFR Parts 50 and 55 (RIN 3150-AJ11; NRC-2012-0031)

On October 25, 2013, the NRC published a regulatory basis in the *Federal Register* (<u>78 FR</u> <u>63901</u>) to support the potential amendment of its regulations concerning nuclear power plant licensees' onsite emergency response capabilities. The issuance of this regulatory basis document is one of the actions stemming from the NRC's lessons-learned efforts associated with the March 2011 Fukushima Dai-ichi Nuclear Power Plant accident in Japan. The NRC is not seeking public comments on this document.

Proposed Waste Confidence Rule and Draft Generic Environmental Impact Statement; Rescheduling of Public Meetings; 10 CFR Part 51 (RIN 3150-AJ20; NRC-2012-0246)

On October 29, 2013, the NRC published documents in the *Federal Register* (<u>78 FR 64412 and</u> <u>78 FR 64413</u>) rescheduling three Waste Confidence public meetings. The October 24, 2013, meeting in Oak Brook, Illinois will now be held on November 12, 2013; the October 7, 2013, meeting in San Luis Obispo, California will now be held on November 20, 2013; and the October 9, 2013, meeting in Carlsbad, California will now be held on November 18, 2013. The NRC postponed these meetings as a result of lapsed appropriations. The NRC will publish notices for other postponed and rescheduled Waste Confidence public meetings as soon as practicable.

ROP Monthly Public Meeting

On October 23, 2013, the staff held the Reactor Oversight Process (ROP) monthly public meeting. Discussions included updates on operational support, inspection, assessment topics, and possible changes to the performance indicator guidance. The staff and industry also discussed Frequently Asked Questions.

Issuance of D.C. Cook NFPA 805 License Amendments

On October 24, 2013, the staff approved the Donald C. Cook Nuclear Plant, Units 1 and 2, license amendments to transition to National Fire Protection Association Standard 805 (NFPA 805). This is the second non-pilot plant to transition to the risk-informed, performance-based fire protection rule. As part of the implementation of NFPA 805, the licensee is making safety improvements to reduce the risk associated with a fire.

Software Certification Consortium Workshop

On Oct 28-29, 2013, the NRC hosted a workshop of the "Software Certification Consortium" focused on safety-critical digital systems. Participants exchanged information about the state of the art in establishing the design bases, derived requirements, and architectural constraints, through modern hazard analysis techniques. Presenters included world-renowned experts from the Software Engineering Institute, Massachusetts Institute of Technology, University of York UK, and the U.S. Naval Research Labs (NRL). NRC staff exchanged information with experts from other federal agencies (Food and Drug Administration, National Aeronautics and Space Administration, Naval Research Laboratory). Discussions included ways and means to leverage insights from the state of the art and apply them to current practice in nuclear power plants.
