MEETING WITH THE NUCLEAR ENERGY INSTITUTE TO DISCUSS

SEISMIC HAZARD REEVALUATIONS ASSOCIATED WITH

IMPLEMENTATION OF JAPAN LESSONS-LEARNED NEAR-TERM

TASK FORCE RECOMMENDATION 2.1, SEISMIC

On January 23, 2014, the Nuclear Regulatory Commission (NRC) staff held a public teleconference meeting<sup>1</sup> with the Nuclear Energy Institute (NEI) and other stakeholders. The purpose of this meeting was to discuss issues relating to the development of the seismic hazard reevaluations submittals related to Enclosure 1, Recommendation 2.1: Seismic of the March 12, 2012, NRC request for information per Title 10 to the Code of Federal Regulations, Section 50.54(f) letter<sup>2</sup>.

To facilitate the discussion NEI representatives gave a presentation<sup>3</sup> that described prior seismic hazard studies, risk and safety assessments, industry plans for interim actions and evaluations in response to the reevaluated seismic hazards, and updates to the March 2014 submittal template. The NRC staff discussed development of a letter to reactor licensees related to operability and reportability quidance for the reevaluated seismic hazards planned for issuance in early February 2014. No regulatory decisions or commitments were made during the meeting.
